ChatGPT



ChatGPT is a Generative AI-powered productivity tool that writes, brainstorms, edits and explores ideas with you.

Browse the web

New versions allow you to access the web.

Content creation

Assists in generating content for emails, blogs, social media, and marketing materials.

Education and tutoring

Offers explanations and answers to academic questions.

Upload files

For assistance summarizing, writing or analyzing.

Graphs and charts

Analyze data and create charts.

Language translation

Translates text between different languages.



Microsoft 365 Copilot



Copilot is an Al-powered productivity tool that is embedded in the Microsoft 365 apps that we use every day.



Draft emails, summarize email threads, and get coaching tips (tone, clarity, etc.)



Create a presentation from a prompt or word file and light commanding (adding slides, formatting, etc.)



Summarize a chat (up to 30 days) and summarize meetings with key points, task owners, and next steps



Get suggestions for formulas, chart types, and insights about data in your spreadsheet




Generate content, summarize documents, and ask questions about your document via chat



Use prompts to draft questions and suggestions that help you create surveys, polls, and other forms



Summarizing Meetings & Documents

Problem/Opportunity: Manually transcribing meetings is a time-consuming task, and oftentimes actions get missed and have to be repeated at a later date or are forgotten altogether. Large legal documents can be voluminous and time consuming, and the same problems persist.

GenAl Solutions

- Summarizing Meetings: Auto-generating transcripts of hours-long meetings, capturing and assigning tasks.
- Document Insights: Rapidly review documents to look for discrepancies, turn documents into live items you can ask questions too.

Problem/Opportunity: Dispersed data storage hampers efficient data querying and retrieval in many organizations.

GenAl Solutions

- Enabling Interface:
 Simplifies data mining and analytics report generation.
- Speed to Insight:
 Enhances business intelligence access and reduces time for insight generation.

Drafting contracts and SoWs

Problem/Opportunity: Drafting Requests for Proposals (RFPs) and contracts and then generating Statements of Work (SoWs) requires significant time and resource investments.

GenAl Solutions

- Automated Drafting:
 - Generative AI can automate the RFP and SoW writing process by generating the initial drafts based on templates, historical documents, and more
- Extracting Information:

Extract relevant clauses and requirements from existing documents. Can be used to create new contracts or assess the risks posed by existing contracts

Content Creation - Al-Enabled Creative Tools

Problem/Opportunity: Content creators face challenges with the volume and management of content, requiring significant time and resources.

GenAl Solutions

- Creative Assistant Tool:
 Creates and edits content with
 Al commands for efficiency.
- Picture Editorial:
 Manages and tags footage using
 Al for faster content curation.
- Al Reshoots:
 Generates new content and edits without the need for physical reshoots.

Current and proposed Al legislation

The Al landscape is rapidly evolving, with proposed and approved regulatory effort



- Algorithmic Accountability Act proposed at the federal level
- Several efforts at the state level related to privacy rights and consumer protection, affecting AI systems handling personal data



- Al Act proposed to categorize Al into unacceptable, high, and minimal risk
- General Data Protection Regulation (GDPR) implications for AI including restricting decisions based solely on automated processing



 New Generation Al Development Plan as a strategic framework that includes national standards and ethical guidelines for Al



 Artificial Intelligence and Data Act (AIDA) proposed to establish a framework for AI system governance and focus on risk assessment and mitigation for high-impact AI systems


Getting started
